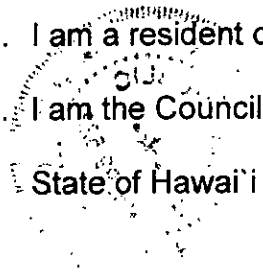

2. I am the Council member representing District 9, in the County of Hawai'i,



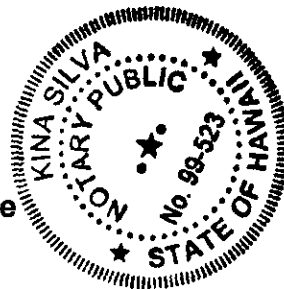


