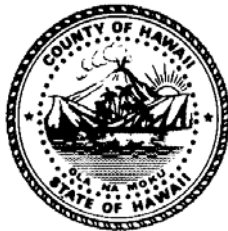

RE: LASERFICHE DOCUMENT MANAGEMENT SYSTEM PROVIDES GREATER ACCESS TO THE PUBLIC

Hyperlink access to documents on Hawai'i County Council and Committee Meeting agendas is back. Not only has this resource to the public been restored, it has been expanded and improved.

As of June 10, 2008, the website for the Office of the County Clerk and the Hawai'i County Council will contain an internet link to a new document management system called Laserfiche.

Laserfiche is an evolution from the current document management system utilized by the Office of the County Clerk and Hawai'i County Council. This technology will provide a multitude of new features for both internal and general public use.

In addition to its internal applications, Laserfiche provides 24/7 instant public access to County-generated documents such as: Council and Committee meeting agendas, Bills, Resolutions, Ordinances, Communications, Notices, and Committee Reports. The public can currently access these documents through Laserfiche for the 2006-08 Council term and will be able to search the archives of previous terms in the near future. The Laserfiche weblink also has basic and advanced search capabilities, which allows for the user to simply punch in a keyword to find all related documents.

“We needed Laserfiche to evolve as an office with critical document management requirements,” said County Clerk Casey Jarman. “The expanded public access to
