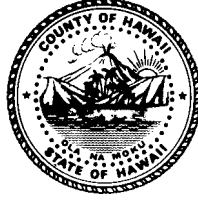

(Bill 133) AN ORDINANCE AMENDING CHAPTER 24 OF THE HAWAI'I COUNTY CODE 1983 (1995 EDITION) RELATING TO VEHICLES AND TRAFFIC (Mamalaho Highway – Route 11, Mid-Block Crosswalk)

McClure, dated July 9, 2003, stating their Traffic Division is requesting the mid-block crosswalk located in front of the Central Kona Union Church be deleted and moved to a more appropriate location by Ala Ke'eke'e Place. Approximately 50 percent of the church congregation supports this proposal.
