- Comm. 24.8: TRANSFER OF FUNDS - APRIL 1-15, 2005  
From Deanna Sako, Controller, dated April 21, 2005, transmitting a Report of Transfers Authorized showing transfers made from April 1-15, 2005, and copies of the approved transfer forms.
- Comm. 222:  
(Res. 82-05) A RESOLUTION TRANSFERRING/APPROPRIATING AN APPROPRIATION OUT AND FROM THE DESIGNATED FUND ACCOUNT(S) AND CREDITING SAME TO A DESIGNATED FUND ACCOUNT(S) (transfers \$32,000 out and from the Clerk-Council Services-Contingency Relief account, and credits same to the Transfer to Capital Projects Fund for the Department of Parks and Recreation - Pāhala Swimming Pool Repairs); and
- (Bill 83) AN ORDINANCE AMENDING ORDINANCE NO. 04-75, AS AMENDED, RELATING TO PUBLIC IMPROVEMENTS AND FINANCING THEREOF FOR THE FISCAL YEAR JULY 1, 2004 TO JUNE 30, 2005 (adds the Pāhala Swimming Pool Improvements project for \$85,000)  
From Councilmember Bob Jacobson, dated April 15, 2005, transmitting the above resolution and bill. Currently, the motorized equipment serving the swimming pool is inoperable and needs to be repaired or replaced. The pool facilities cannot be used until the motor is repaired. The \$85,000 appropriation includes the transfer of \$32,000 proposed in the above resolution and the transfer of \$53,000 that was approved on December 21, 2004, by Resolution 18-04.

(Bill 85) AN ORDINANCE AMENDING ORDINANCE NO. 04-75, AS AMENDED, RELATING TO PUBLIC IMPROVEMENTS AND FINANCING THEREOF FOR THE FISCAL YEAR JULY 1, 2004 TO JUNE 30, 2005 (adds the Waipi'o Valley Stream Debris Removal project for \$50,000)  
From Finance Director William Takaba, dated April 12, 2005, transmitting the above bill. This project proposes to remove debris from the streams in Waipi'o Valley that were deposited by the April 2004 flood. This appropriation is only for the Federal share or 75 percent of the total project cost. The remaining 25 percent will be provided by the County in the form of in-house services.
- Comm. 227:  
(Bill 86) AN ORDINANCE AMENDING ORDINANCE NO. 04-74, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2005 (appropriates \$172,000 to the Streetlights - Other Current Expenses {\$135,000}, and Puna Road - Other Current Expenses {\$37,000} accounts)  
From Finance Director William Takaba, dated April 13, 2005, transmitting the above bill. At the March 16, 2005 County Council meeting, Bill 40, was amended to Draft 4 to include \$20,000 for the streetlights in District 3 and \$25,000 in District 4. On April 6, 2005, Bill 40 was amended to Draft 6 to include \$37,000 for the Volcano Charter School Shoulder-Paving project, \$25,000 for streetlights in the Ainaloa Subdivision and \$65,000 for streetlights in District 2.

(Res. 85-05) RESOLUTION AUTHORIZING THE ACCEPTANCE OF A MONETARY DONATION OF \$500 TO THE HAWAI'I COUNTY POLICE DEPARTMENT (donation from the Kona Coast Resort for the Hawai'i County Police Department's Special Response Team); and
- (Bill 87) AN ORDINANCE TO AMEND ORDINANCE NO. 04-74, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2005 (appropriates a donation of \$500 to the Police Department's Administrative Division - Other Current Expenses account)

(Res. 86-05) RESOLUTION AUTHORIZING THE DIRECTOR OF FINANCE TO NEGOTIATE A LEASE AGREEMENT FOR THE FORMER CARETAKER'S COTTAGE AT SPENCER PARK AT 'OHAI'ULA BEACH TO THE HISTORIC HAWAI'I FOUNDATION (located within Tax Map Key: (3) 6-2-02:08)  
From Finance Director William Takaba, dated April 19, 2005, transmitting the above resolution. The building is currently in unusable condition and would be restored for public use if leased by the Historic Hawai'i Foundation.

(Bill 90) AN ORDINANCE TO AMEND ORDINANCE NO. 04-74, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2005 (appropriates \$7,140 to the Solid Waste Fund - Recycling Program account)  
From Finance Director William Takaba, dated April 19, 2005, transmitting the above bill. Bill 40, Draft 6, which passed second and final reading on April 6, 2005, included \$7,140 for the Hāwī Recycling Facility Upgrade project. This bill appropriates those funds to the Solid Waste Fund's Recycling Program account.

(Bill 91) AN ORDINANCE TO AMEND ORDINANCE NO. 04-74, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2005 (appropriates an additional \$12,500 to the Department of Environmental Management - Used Oil Collection and Disposal account)  
From Finance Director William Takaba, dated April 19, 2005, transmitting the above bill. The State of Hawai'i Department of Health has increased its annual grant funding solely for the purpose of conducting education and public outreach for the Used Oil Collection Program.
